

What is the Dentist and Dental Hygienist Compact?

The Dentist and Dental Hygienist Compact is an interstate agreement that allows licensed dentists and dental hygienists to practice in multiple participating states without the need to obtain additional state licenses. It establishes a streamlined pathway for dentists and hygienists to obtain a 'Compact Privilege,' enabling them to practice in participating states while holding a primary license in another member state. This compact is legally binding and enacted by each state's legislature to join the agreement.

What is a Compact Privilege?

A Compact Privilege is the authorization to practice in a remote state under the compact while holding a primary license in another participating state. It allows hygienists to practice legally in states where they are not directly licensed

Who is Eligible for the Compact?

Dental hygienists with an active, unencumbered license in a participating state who meet educational, examination, and background check requirements

How Will Licensing Work?

Once the compact is enacted, eligible dental hygienists can apply for a Compact Privilege through the commission. The process includes verification of licensure, a background check, and meeting any additional state-specific requirements such as jurisprudence exams

How Licensing Will Work When the Compact Starts

Apply for a Compact Privilege

Submit an application through the compact commission's platform.

Background Check

Complete a national background check and provide any necessary documentation.

License Verification

The compact commission verifies your license status and educational credentials.

Jurisdiction-Specific Requirements

Meet any additional state requirements, such as jurisprudence exams.

Receive Compact Privilege

Once approved, you can begin practicing in the remote state as long as you maintain your primary license in good standing.
